

# **BEACON®**

Use this Quick Reference Guide to complete a BEACON® billing cycle for mobile systems using ORION® Mobile Read and the BEACON Monitor export.

### STEP 1

Create a .csv file from the CIS/billing

**system** 1-day prior to meter reading

### In CIS/billing system

- □ Create the file using the steps outlined by the CIS/billing system provider
- □ Save the file in the location noted below

# STEP 2

Perform a **System Sync** 

#### In BEACON

- ☐ Go to System Sync > Data Exchange
- ☐ Click **Select File**, then browse to and select the .csv file created in Step 1
- □ Review any Exceptions and take action as needed.
- □ Click on the **Approve** button to accept the CIS/billing file and apply the data. Please Note: Best Practice is to let the import fully process overnight before moving on to the next step.



### STEP 3

**Create Field Assignments** 

### In BEACON

- ☐ Go to **Monitor** page and use the filters to select the meters to be read
- □ Click **Actions** then select **Create Field Assignments** from the drop down
- □ Select appropriate user to receive the Field Assignments
- □ Check the box to **Replace Existing Field Assignments**
- □ Click **Create**



#### STEP 4

**Collect the meter** read data

### On the mobile data collection device

- □ Collect meter reading data using ORION Mobile Read software
- □ Synchronize ORION Mobile Read meter reading session data with BEACON

Please Note: It may take time for synchronized reads to fully integrate into the BEACON database and be ready for export.

# STEP 5

Prepare the billing reads for export to CIS/billing system

#### In BEACON

- □ Go to the **Monitor** page
- □ Click Actions > New Export
- □ Select the **Billing Reads Export** type, set the **Billing Read Date** and **Read Time Tolerance**
- ☐ Click **Start Data Export**
- □ Click **Download Billing File**
- □ Save the billing file in the desired location using the name required by your billing software
